- **Opening remarks, Introductions, Agenda review, Approve minutes – Jeff Crouch, Dr. Dave Peterman**
 - ❖ Dr. Peterman and Jeff Crouch welcomed everyone. As we transition away from a volume based model and move towards a value based payment model, it will be important that all payers participate.
 - ❖ Members provided brief introductions. Jamie Berger, the newest member, will be representing Noridian a Medicare Administrative Contractor (MAC). Noridian wants to be creative in supporting the SHIP without having to change legislation.
 - ❖ Notes of the 12/10/2014 meeting were accepted as prepared.
- **Approve Charter and Review Timeline for Deliverables – Jeff Crouch, Dr. Dave Peterman, Yvonne Ketchum**
 - ❖ The workgroup fleshed out the Charter. Yvonne will update the document with the group's revisions.

MOTION: Larry Tisdale moved to approve the charter with the name change to IHC Multi-payer Workgroup, the addition of Jamie Berger as a member and to have the Milestones and schedule moved out of the charter and into a work plan, the motion was seconded by Lisa Hettinger and passed unanimously

❖ The milestones and schedules piece will be brought back to the next meeting as a work plan.

- **Discuss Scope and Review – Jeff Crouch, Dr. Dave Peterman**

- ❖ The payers discussed and agreed to form an attribution methodology for all patients that could be attributed to a practice. There will still be patients who will not attribute because they have not sought medical care. The payers value based payment will be for all attributed patients, not just the chronically ill.
 - ❖ There was a commitment by payers to move to value based payments on or before January 2016.
 - ❖ Jamie Berber will try and locate documents discussing the Medicare program launching 1/1/15. She will forward the material to the workgroup through Jeremy.
- **Discuss Topics for Next Meeting – Jeff Crouch, Dr. Dave Peterman, Yvonne Ketchum**
 - ❖ Review timeline for work plan
 - ❖ Review practices that are already enrolled as a PCMH.
 - ❖ Meet with Dr. Andrew Barron to review Quality Committee recommendations for measures
 - ❖ Jeff proposed that payers come to the February meeting to discuss attribution readiness.
 - ❖ The workgroup will need to have additional discussions at the February meeting around attribution for patients with primary and secondary insurance.

With no further business to come before the board, Chairman Crouch adjourned the meeting at 1:25p.m. without objection.
